Department of Education and Youth

Background to the Role:

The Department of Education and Youth is seeking to second a Primary or Post Primary teacher to the role of National Director for Creativity and Arts in Education. The successful candidate will work with the Curriculum and Assessment Policy Unit of the Department of Education and Youth, and Tralee Education Centre. The overall remit of the National Director will be to design, lead and manage the national coordination, support and effective delivery of the implementation plan for the Department of Education and Youth-led Creative Youth initiatives under the Creative Ireland Programme 2023-2027.

They will have overall responsibility for ensuring quality of design and provision in the Department of Education and Youth-led Creative Youth initiatives and where appropriate, consistency and cohesion across Ireland. The post will encompass team leadership and strategic planning in promoting continuous improvement in leadership, pedagogy and practice through creativity in schools, while responding to national Department of Education and Youth and Creative Youth professional development priorities.

The National Director will collaborate with and have a line management function for leading, overseeing and supporting the work of the Advisor for Creativity and Arts in Education and the Creative Connections Coordinator. In collaboration with the Director of the Education Support Centre Tralee they will advise, lead and oversee the work of an administrative team in the National Arts in Education base in Tralee.

1. Key responsibilities of the National Director will be to:

- Working with the Curriculum and Assessment Policy Unit of the Department of Education and Youth and Director of Tralee Education Support Centre.
- Informing and influencing the national strategic direction of the Department of Education and Youth-led Creative Youth 2023-2027 initiatives: BLAST (Bringing Live Arts to Students and Teachers), Creative Clusters, Creative Connections, I am Creative, Teacher Artist Partnership+
- Be responsible for the overall planning, designing, scheduling, delivery, monitoring and reviewing of the Creative Youth professional development programmes within their remit in response to identified needs and national priorities.
- Contributing to the overall mission and vision of the Department of Education and Youth and Creative Youth Plan through the effective delivery of annual and multiannual work plans.
- Supporting, advising and liaising within the Department of Education and Youth and externally on an ongoing basis, including on the inclusion of Youth Voice across all Creative Youth initiatives
- Cooperating, liaising regularly and maintaining effective communication with relevant partners/stakeholders and professional bodies as appropriate.
- Networking and collaborating with other relevant bodies including partners in Creative Ireland and others such as Teacher Professional Networks, Encountering the Arts

- Ireland, the Arts Council, the NCCA, Teaching Council, HEIs and other external agencies as appropriate.
- Promoting excellence, innovation and best practice in the development in schools as learning communities through the development of "Communities of Practice" and "Professional Learning Communities".
- Co-operating with external evaluators and contributing to research as applicable.
- Implementing instructions and establishing efficient, effective and transparent administrative supports to include:
 - Advising regarding administrative staff duties to support all Department of Education and Youth-led Creative Youth initiatives
 - Develop practical systems to facilitate the delivery of high quality online and digital supports for all stakeholders.
 - Managing and timely preparation of budgets, monitoring expenditure, resource allocation and the development of and compliance with financial reporting in collaboration with the Finance Officer, thus ensuring good governance and value for money for initiatives.
 - Overseeing the development and management of appropriate databases on behalf of Tralee Education Support Centre and the Department of Education and Youth.
 - o Preparing reports and other data on an ongoing basis as required.
 - Other responsibilities as may be required by the Department of Education and Youth.
- Liaise and work with partners on the Arts in Education Portal Committee and the Arts and Culture in Education Research Repository (ACERR)
- Liaise and work with partners in Education Centres and school education settings including principals, teachers, centre managers, and Government Partners on the Department of Education and Youth internal Creative Youth Steering Committee and inter-Departmental Creative Youth Working Group

The priorities of the National Director for Creativity and Arts in Education may vary in accordance with emerging national needs and priorities.

2. Range of knowledge, experience and skills required:

Essential requirements for this role include:

- Excellent leadership, interpersonal, management and organisational skills with a proven track record in team/service leadership and innovation
- An extensive range of teaching experience including design and delivery of teacher and creative practitioner professional learning.
- An excellent knowledge of national curricula, international trends in creativity and education, the operation of schools, relevant legislation and the education system generally.
- Excellent planning and coordination skills, including knowledge and experience in data collection, budgeting, financial reporting and report writing.
- Good governance and financial management skills.
- Excellent people management and motivation skills with a keen interest in research and evidence based reflective practice.

- Excellent track record with proven and varied experience in leading teacher professional learning, including evidence of a capacity to mobilise and support teacher reflection, enquiry and classroom-based research.
- Have experience of the inclusion of Youth Voice in education and establishment of Youth Consultation mechanisms.
- Demonstrated ability to pro-actively manage and coordinate the work of others teachers, creative practitioners and/or administrative staff and colleagues.
- Proven capacity to work independently and collaboratively, including leading teams.
- Evidence of successful support for the implementation of innovative and effective creative and artistic pedagogies.
- Flexibility to meet the business needs of the organisation/team, including a willingness to engage in travel and/or evening work as necessary.
- A creative enterprising approach to tasks and the capability to undertake the innovative and challenging elements of the work.

3. Desired:

- Demonstrated leadership experience in the integration of creativity and the arts in education both nationally and internationally.
- Competence in and willingness to work through Irish.

4. Location: In carrying out his/her work, the National Director will:

- Be seconded to Tralee Education Centre for a period of one year, which is renewable.
- It will not be a requirement that the National Director be based in Tralee Education Support Centre. They will, however, be expected to travel there and elsewhere as necessary.
- The successful candidate will be required to have their own means of transport and to possess and retain a full clean driving licence. Public Sector travel and subsistence rates will apply.

5. Eligibility

- This post is open to all qualified teachers who hold a recognised post in a recognised primary or post primary school and are fully registered with the Teaching Council under the appropriate Teaching Council Registration Regulation (i.e. Regulation 2 or 4 of the Teaching Council (Registration) Regulations 2009 up to 25th July 2016 or Route 1 or 2 of the Teaching Council (Registration) Regulations 2016 and The Teaching Council (Registration) (Amendment) Regulations 2016 thereafter.
- Any offer of appointment will only be made where it is considered that a suitable candidate for the post exists.
- The appointment is subject to the sanction of the Department of Education and Youth.
 No definitive offer of appointment can be made before sanction is given.
- The appointment is on a secondment basis, subject to contract. The successful candidate will be appointed initially to the end of the school year 2025/2026, with a possibility of further extensions available in line with organisational requirements and the procedures for secondments set out in CL 0029/2018.
- The contract will provide for ongoing performance review.
- Health, sick leave and general work record must be satisfactory.

6.Salary

The salary for the role of National Director for Creativity and Arts in Educations is in accordance with the 2003 Arbitration Award in respect of teachers on secondment, subject to the following conditions.

- A degree allowance (Depending on date of entry as set out in below tables)
- A Higher Diploma in Education allowance (Depending on date of entry as set out in below tables)
- The standard Category 2 secondment allowance per Circular Letter 0015/2025
- It should be noted that posts of responsibility allowances are not payable to seconded personnel. If an applicant is already in receipt of a Post of Responsibility Allowance, he/she should note that they will not be allowed to retain this in a personal capacity for the duration of their secondment.
