The Board of Management of St. Patrick's National School, Diswellstown is seeking a secretary on a part-time, permanent basis.  
The position will be subject to the terms of Circular 0036/2022 Revision of Salaries and Annual Leave Arrangements for School Secretaries. The entry-level for this role is on the first point of the scale, unless the candidate has previous work experience as a School Secretary.  
The appointment is subject to Garda Vetting and the successful candidate will be required to undertake TUSLA Child Protection Training. This position is subject to a probationary period. Handover and induction training will be facilitated.  
The School Secretary is an integral part of the school community, working closely with the school principal, and will manage the school office in a welcoming, professional, and discreet manner. This position requires experience in office management and administration and experience within an educational setting is preferable.

The successful candidate will have :

- o Excellent interpersonal and communication skills (both oral and written)
- o Administrative and secretarial skills
- o Proficiency in ICT including word processing, spreadsheets, email etc.
- o Knowledge of GDPR & Data Protection requirements.
- o Excellent organisational skills, ensuring good record-keeping, filing (electronically) and adherence to school procedures & policies.
- o The ability to work on own initiative and as part of a team
- o Reliability, trustworthiness and strict adherence to confidentiality
- o Flexibility and adaptability to the needs of the school
- o Knowledge in operating and maintaining a school online banking and payment system.
