We have a Full day post available (32 hours per week). Experience working with children with special educational needs is desirable. Applicants should also demonstrate their ability to work as part of a school team under the direction of the class teacher, special education teacher and Principal and display a strong work ethic. Confidentiality and discretion are essential. Desirable skills include:

- willingness to undertake courses which relate to the needs of the children and of the school
- suitability to the school and the needs of the pupils of the school
- adherence to the ethos and culture of the school

Qualifications as set out by the DES for this post (see DES Circular 0051/2019). Having other relevant qualifications in areas such as First Aid Certification, Epilepsy and Administration of Rescue Medication Certification etc is desirable.

Duties of the post are as outlined in DES Circular 003/2014 and other relevant circulars. Duties of the post are subject to change depending on the care needs of the pupils in the school. Successful candidates will be expected to complete 72 hours (as per DES Circular 71/2011) throughout the year.
