Hansfield ETSS is large secondary school in Dublin 15 under the patronage of Educate Together. It caters for over 850 students from a wide variety of cultural, socio-economic and educational backgrounds, including 18 students in our three Autism Classes (AS).

As a large school it provides a lot of opportunity for creativity and innovation. New subjects such as PE and Computer Science have been introduced at Senior Cycle. One-to-one Devices were introduced for first years in September 2023 and there is a strong commitment to professional development for staff with good opportunities for career consolidation and promotion over time.

Vacancies that arise in 2026/2027 are set out at the end of this Information Note. Some are linked to the new positions and others to staff secondments, career break, job sharing. The final employment status and number of hours offered will depend on the final teacher allocation approved by the Department of Education & Youth and the qualifications and subject combination of the successful candidate.

- working on developing curriculum initiatives.
- working with students with different abilities and additional educational needs (AEN).
- working with students for whom English is a second language.
- working on or leading guidance initiatives and/or behaviour support initiatives.

-Successful candidates will be required to commit to the following:

- exploring innovative teaching and learning, including collaborative practice, team teaching, experiential learning and using ICT as a primary teaching and learning tool
- collaborating with colleagues for subject planning.
- mediating the curriculum through integrated and theme-based learning initiatives focussing on experiential and discovery-based learning
- promoting school wide ethical education, ethical practice and development education
- supporting positive behaviour focussing on the principles of restorative practice

- building the school ethos and culture as framed by the Patron Body
